## Fordham and Dominion Brewing's Annual 2019 Beer and Music Festival



Fordham & Dominion Brewing Co. in Dover has begun the countdown to the R2Hop2 beer and music festival which will be held on Saturday, April 27<sup>th</sup>. ### VENDOR OVERVIEW:

1. Vendor will display and sell artwork and crafts during the R2Hop2 event Saturday, April 27, 2019 from 12:30 - 6:00 pm. Vendor must provide a 10x10' tent, table(s) and chairs. Exhibit space fee is \$100 for a 10x10' area. All entries must be non-food items. Resale items are not allowed. This is an outdoor event that will be held rain or shine.
2. Vendor is responsible for delivery, set up, financial transactions, and removal of all contents, structure and trash. Craft Vendors or a representative must be present for the duration of the event and handle all their sales/taxes.

3. Email us 1-3 images in high resolution jpeg format of your craft for publicity and give the Fordham & Dominion Brewing Company/Coastal Brewing Company the right to use images for the purpose of marketing the event.

Please make sure the number of space(s) you select will provide enough room to accommodate your entire vendor set-up (tents, tables, etc.). **If your set-up does not fit within the basic 10x10' space, then you must request and pay for 2 full spaces.** (For example, if your set-up is 18x10', then you must purchase two (2) full spaces at \$100 each, totaling \$200 and you will be assigned a 20x10' space). **If upon arrival it is determined that your space requirements for your set-up do not match what you have indicated on this contract, you will not be permitted to set-up for the event. There are no exceptions!** We cannot and will not make space re-arrangements once sites have been plotted out and configured to match the information on this contract. Tents must be staked and weighted properly.

**Hours of Operation and Vendor Set up:** There will be Vendor set up the morning (Saturday) of the event between the hours of **9:30 am and 12:00 pm**. Please be on time. No vehicles on the Festival grounds after 11:30 am. The event is scheduled to begin promptly at 12:30 pm. You must be completely set up by 12:00 pm. **Vendors will NOT be allowed entry onto the festival grounds to set up after 11:30 am.** **There will be no early break-downs.** Vendor booths must remain intact and accessible for sales from 12:30 pm - 6:00 pm. All personal equipment and inventory belonging to the vendor must be removed Saturday immediately following the R2Hop2 event. You are responsible for cleaning up your space COMPLETELY. Please leave the space as you found it. You will receive (1) vendor parking pass and (2) vendor wrist bands per 10x10' space. Additional help or companions must purchase tickets.
